Decennial Review

Impact film training – places open to JRCT grantees

As part of our Decennial process, we are also looking at ways of illustrating the impact of work that we fund.

We are offering a workshop for staff from projects funded by JRCT, to learn how to make short films about the impact your project makes. Selected participants would come together for 24 hours to design and film six short films, one for each project. The finished films would be for your organisation to use and will also be edited together into one film for use by JRCT.

The workshop is likely to take place in London in May or June 2018, running from one lunch time until the next. JRCT will cover all costs of the training, and travel, for the participants.

We are looking for representatives from six projects, ideally two people from each project. It is up to you who you nominate, but we suggest ideally one person responsible for marketing/evaluation and one front line worker/volunteer. We know these categories won't apply to all grantees.

JRCT is making the offer of this training to all grantees and will select attendees from those who respond to the offer, to get a good mix of different organisations.

Divestment target reached

We are delighted that JRCT entered 2018 with no investments in fossil fuel extractive companies.

In 2014 we were the first European foundation to sign up to the Divest Invest Philanthropy Pledge, committing to divest from all such investments by 2020. We are concerned that, if all the reserves of coal, oil and gas that sit in these companies' balance sheets are burnt, it will make it nigh on impossible to keep global temperatures within the internationally agreed range. The risks of more extreme climate change are so serious that all investors have a responsibility to act.

Given the urgency of the issue, we have appreciated our fund managers' willingness to work with us on achieving not only our target but getting there substantially ahead of time.

That said we do not regard it as a job done. We continue to focus on the sustainability of our investments, not only to generate good financial returns for ourselves as investors, but for wider public benefit. We also continue to support organisations through grants that advocate for more responsible approaches by companies, investors and pension funds.

Nick is a Senior Lecturer in Politics at the University of York. Nick brings academic expertise on nuclear disarmament to the Committee and has worked on disarmament issues since 1999.

Lisa Faulkner-Byrne has joined our Northern Ireland Committee. Lisa brings a background of academic research and teaching in social policy and broad experience of the community and voluntary sectors in Northern Ireland.
